Who can enter?



The everywoman in Transport and Logistics Awards recognize individuals who embody the industry's core values: qualities, a strong work ethic, dedication to supporting fellow women, and contributions to both their organizations and the sector. These exceptional women not only meet but exceed expectations, serving as inspirations to others.

The awards are inclusive, open to women at all career stages.

Entrants may self-nominate or be nominated by others, with the option to enter a maximum of two categories. The criteria for entry are as follows:

- Work within a transport and logistics based role
- Be based or have their chief operations in the UK or Ireland (excluding the International Inspiration Award)
- Be available for a judging day on 23 April 2024 and the awards ceremony in London on 27 June 2024

Top tips for completing a nomination

To stand out in the everywoman in Transport and Logistics Awards, a meticulously completed nomination form is your ticket to recognition.

Take your time to craft a compelling nomination, leaving no stone unturned in showcasing the nominee's brilliance. Double-check that all contact details are accurate.

Remember, you can save your progress and return to your entry using the [link sent via email](#). However, once the final version is submitted, no further edits can be made.

Pay special attention to the bullet points that outline what the judges are seeking in the executive summary. You have a **750-word limit** in this section to concisely present the nominee's achievements.

- Provide sufficient detail to convey the nominee's accomplishments.
- Be specific and stay focused.
- For additional in-depth information, utilise the uploaded supporting evidence (refer to the next slide).



Support your nomination

- Remember, you can submit supporting evidence for your nomination in the form of press releases, news articles, photographs, testimonials or other items which you think will help the judges make informed decisions about the nominee's business
- Please submit any supporting documents together in one document, 4-sides maximum. In addition to this you can also submit a video URL link if appropriate.
- Supporting evidence can be attached via the UPLOAD button at the bottom of the nomination form (supporting evidence must be uploaded before submitting your finished nomination)



Personal achievements

- What achievements has the nominee made in their business career – have they won any awards, qualifications or accreditations?
- What personal achievements has the nominee made that has inspired them to become successful in business – have they climbed a mountain, completed a marathon, invested in other successful businesses or lobbied the local council for change?

Judging process



All successful entrants will be contacted by the last week of March 2024, if required to attend Judging Day on 23 April 2024.

If selected, the Awards ceremony in London is on 27 June 2024. This is a condition of entry.

There will be two winners per category (Leader and Above and Beyond) as well as one recipient of the Industry Champion, Male Agent of Change, Apprentice of the Year and Woman of the Year Award.

All decisions regarding the judging process are made by our independent judging panel. The everywoman team do not influence this process.

The judges' decision will be final and no correspondence will be entered into before or after the judging.

Due to the large number of nominations received, the judging panel are unable to provide individual feedback.
